KEATON OTIS was shot 23 times by Portland police in May, 2010.

He had committed no crime.

He "looked like a gangster" they said. "He was wearing a hoodie."

Video* records Keaton shouting, "I've got my hands up." An officer orders, "Let's do it!"

The officers are still on patrol. And there is still no justice for Keaton Otis.

THE OFFICERS who shot Keaton Otis 23 times claim that he had a gun and shot a cop, twice.

The cops of HEAT say they fired in self-defense -- in a 7-second frenzy of 32 shots. Nine missed.

- * The Taurus handgun allegedly used by Keaton Otis held rounds with gold-colored casings. No gold casings were found at the crime scene. One appeared in evidence two days later.
- * Keaton Otis was in the driver's seat when he was shot while he had his hands up. Seven shots hit him in his left arm, wrist and hand.
- * No finger or palm prints were found on the gun or casing. The gun was not linked to Keaton Otis in any way. No residues were found on him.
- * The officers who dragged Keaton Otis's body from the car say they never saw a gun.
- * All three officers who shot Keaton Otis from point-blank range specifically deny seeing the gun. None could describe it to detectives.
- * The gun was stolen in 2006, but its owner forgot to report it. Where was it for 4 years?
- * The gun was found sitting on the driver's seat an hour after the shooting.
